

WHY ARE THE PHYSICIAN DOCTORS A WITCH?

The main reason why most people have been perceived as blind spots about physician doctors who are the same as witches is because of their ancestors who never taught about it. Why do you think the book of **Job 13:4** for the LEB version said “...you whitewash with lies; all of you are worthless healers” and the KJV version said “...ye are forgers of lies, ye are all physicians of no value” and also the CJB version said, “...you, what you do is whitewash with lies; you are all witch doctors!”?

The passage verse we just read, describes what is a witch and what are they being called. Those who believe they are a healer like a physician are called witches. Not only do they perform as physician doctors, they also perform magic according to 2nd Kings 17:17:

“They sacrificed their sons and daughters in the fire. They used magic and witchcraft to try to learn the future...”

The same thing for how the scripture describes in the book of Deuteronomy 18:9-12:

“When you come into the land that אֲרָצְךָ, your Supreme Father is giving you, you shall not learn to follow the abominable practices of those nations. There shall not be found among you anyone who burns their son or daughter as an offering, anyone who practices divination or tells fortunes or interprets omens, or a sorcerer or a charmer or a medium or a necromancer or one who inquires of the dead, for whoever does these things is an abomination to אֲלֹהֶיךָ. And because of these abominations אֲרָצְךָ, your Supreme Father is driving them out before you.”

Those who use magic like what the necromancers do in their witchcraft perform work, and try to learn the future are sorcerers who also speak like charmers to deceive people into believing. The bottom line here is, that any kind of abomination performed work is witchcraft work. This is why it is a forbidden kind of witchcraft work and it is never taught from the TORAH. This is why the physician doctor and surgeon were never taught from TORAH as well.
